## MEMBERSHIP INFORMATION

**INITIATION FEE:** A one time, non-refundable, non-transferable initiation fee is required when an application to the Tennis Club of Vista is submitted for approval. The amount of the initiation fee is listed below.

**MONTHLY DUES:** Due and payable on the 1<sup>st</sup> day of each and every month of the year, delinquent after the 10<sup>th</sup> day of each month. A \$10.00 late charge will be added after the 10<sup>th</sup>, which must be paid in order to ensure the continuance of a membership. Effective 1-01-08, the monthly dues schedule is as follows:

JUNIOR-----	\$30.00	INITIATION FEE-----	\$100.00
SINGLE (18-25) -----	\$40.00	INITIATION FEE-----	\$100.00
SINGLE (25+) -----	\$70.00	INITIATION FEE-----	\$200.00

FAMILY-----	\$90.00	INITIATION FEE-----	\$300.00

**JUNIOR MEMBERSHIP**---Only unmarried, dependent children under the age of eighteen (18) are eligible. The membership privileges of a Junior Member terminate as of the date such member reaches the age of eighteen or becomes married.

**MARRIED COUPLE**---Only couples who are currently residing together qualify for this type of membership.

**FAMILY MEMBERSHIP**---Married couples and single parents with dependent children under the age of eighteen and residing at home with the parent(s) qualify for this type of membership. The membership privileges of the children shall terminate when the membership privileges of their parents terminate, or as of the date they become eighteen or are married. When a child reaches the age eighteen, he or she will have the option of becoming a dues paying member. Exercise of this option must be applied for within thirty days of the person's 18<sup>th</sup> birthday. In order to qualify for this type of membership, the eligible person must have been listed as part of the family membership or three years prior to their 18<sup>th</sup> birthday.

### **GUEST POLICY:**

A member in good standings is entitled to bring a guest to the club at the cost of \$10.00 per day. The same guest may play at the club only once a month. All guests must be paid for and registered in the Pro Shop before playing.

### **REGISTRATION & COURT SIGN-UP:**

Members and Guests are required to register in the Pro shop for a tennis court assignment before playing. Courts will be assigned for a period of one and one half hours of play if other people are waiting, otherwise, you may play as long as you wish. Courts may be reserved one day in advance by calling the Pro Shop. Reservations will be held for ten minutes after the scheduled time of play, however, if all parties scheduled for the court are not present, the court will be given to those that are waiting. Members must still check in at the Pro Shop before playing even if they have made a phone reservation.
